14 Session 1: Welcome

- 15 The Global Sustainability Standards Board (GSSB) Chair Judy Kuszewski (henceforth the Chair)
- welcomed the GSSB and presented an overview of the meeting agenda.
- 17 The GSSB was presented with Item 05 Draft summary of the meeting held on 10 June 2021 for
- 18 approval
- 19 **GSSB Decision 2021.15** The GSSB resolved to approve Item 05 Draft summary of the meeting
- 20 held on 10 June 2021.

Session 2: Introductory presentation of the Oil & Gas Sector Standard

- 23 The Standards Division (SD) reviewed the objectives of the GRI Sector Standards Program and the
- 24 GRI Sector Standards Project for Oil and Gas, as well as the project's process and progress,
- 25 including a review of the public comment feedback received on the oil and gas content (as opposed to
- the feedback received on format of Sector Standards generally). The SD then discussed the final draft
- 27 of GRI 11: Oil and Gas Sector 2021, with particular attention to changes made since the public
- 28 comment period.
- 29 A GSSB member requested clarification about the inclusion of Disclosure 306-3 in the Sector
- 30 Standard, because GRI 306: Effluents and Waste 2016 has been replaced by GRI 306: Waste 2021.



- 31 The SD confirmed that because effluents had been removed from GRI 306: Waste 2021, the effluents
- 32 related disclosure from GRI 306: Effluents and Waste 2016 will remain effective until such time as it is
- replaced and referenced in GRI 11: Oil and Gas Sector 2021.
- 34 A GSSB member raised concerns that references to forecasts from an International Energy Agency
- 35 (IEA) report which were not intended for decision-making were included in GRI 11. The SD explained
- 36 that these references had been included through the multistakeholder process to develop the Sector
- 37 Standard, and that the forecasts were referenced in the topic description section of the climate
- 38 change adaptation and resilience topic to explain why the industry might find the topic material.
- 39 The SD reinforced that these topic descriptions are intended to provide an organization context to
- 40 determine if the topic is relevant for them or not, and not to provide instructions about how an
- 41 organization should behave. They also invited further input and comments from the GSSB member
- 42 and other stakeholders during the finalization of the draft. The SD member will forward further detailed
- 43 comments on the issue to the SD.
- 44 A GSSB member questioned if and how GRI intended to avoid the situation where an organization
- 45 neglects to undertake stakeholder and materiality assessments, and instead only reports on the
- 46 General Disclosures and Sector Standard disclosures.
- 47 The SD discussed that the requirements for reporting in accordance with the Standards emphasize
- 48 that use of the Sector Standards does not replace the need for a materiality assessment and
- 49 stakeholder engagement. They also highlighted that the Sector Standards will give information users
- 50 guidance about what to look for in reporting from organizations in a sector, which will encourage and
- 51 reinforce the need for organizations to move to more complete reporting over time.
- The SD then presented the proposed timeline and path to approval for the final draft of GRI 11: Oil
- 53 and Gas Sector 2021 and requested that GSSB members provide any feedback on the draft Sector
- Standard to the SD by 25 June 2021, to be addressed before the consideration for its approval on 1
- 55 July 2021.
