Session 1: Welcome 14

- The Global Sustainability Standards Board (GSSB) Chair Judy Kuszewski (henceforth the Chair) 15
- welcomed the GSSB and presented an overview of the meeting agenda. The GSSB was presented 16

Session 2: Key conclusions of the 23 draft Sector Standard for Coal

- 24
- Noora Puro, Manager Sector Program, presented the progress of the Sector Standard project for 25
- 26 coal since the exposure draft was released for public comment. The following points provide an
- overview of public comments received that led to significant changes in the draft Standard: 27
 - The list of likely material topics did not change due to the public comments received.
 - Most of the feedback was related to climate-related topics, followed by comments on topics related to environmental management.
- 31 Key changes to the draft Standard targeted the following topics: Topic 12.2 Climate adaptation, resilience, and transition; Topic 12.3 Closure and rehabilitation; Topic 12.4 Air 32

33	emissions; Topic 12.13 Asset integrity and critical incident management; Topic 12.20 Anti-

- Major revisions were also made in the section describing the sustainability context for the coal sector. The section is titled: The sector and sustainable development.
- The International Council on Mining and Metals has been consulted on a number of topics where an overlap is anticipated with the mining Standard to future proof the coal Standard.
- The presentation concluded with questions and concerns from the GSSB regarding proposed changes to the draft coal Standard. Questions asked by GSSB members and corresponding answers from the SD are as follows:
 - GSSB: What is the weight on transition in the coal Standard compared to the weight in transition in the oil and gas Standard? Do we have the balance right in terms of weight proportional to response?
 SD: The message from the WG is that coal should be treated differently from oil and gas; coal
 - is the priority in the low-carbon transition. Governments and investors are targeting coal to be phased out, as seen in COP26 messaging. Stakeholders and WG members have indicated the urgency to transition away from coal, but it is important to recognize the impacts that existing operations have and will continue to have on communities. Plus, the need to transition and the impacts of those transitions. Therefore, there is a slight increase in reporting related to transition.
 - GSSB: Were there any public comments regarding the sector's scope in terms of what should be reported under transportation?
 SD: We did not receive any direct comments on this, but it has been a discussion point outside of public comment. The scope of this particular Standard would include transportation which will be the same proposal for mining; it is about the transportation of the mineral. General transport, for example, food, supplies, and workers would be best covered by a separate transport Standard.

Session 3: Approval of the proposed working group of the GRI Sector Standard Project for Mining

- Senior Coordinator, Veronica Wachong, presented to the GSSB the composition of the proposed WG of the GRI Sector Standard project for mining:
 - 89 applications were received, and 38 applicants were interviewed; the proposed WG includes 20 members: 18 of those applicants interviewed and 2 nominations from the Council of Global Unions representing labor.



- The WG composition includes representatives from Africa, Asia, Europe, North America,
 Oceania, and South America, large-cap and small/mid-cap representation, a range of
 commodities, and relevant associations.
 - Despite the balance achieved in the proposed WG composition, some limitations need to be addressed through additional stakeholder engagement during the development of the Standard to ensure sufficient coverage of, e.g., less represented geographical contexts, nonmetallic mining, quarrying, artisanal and small-scale mining.
- The GSSB resolved to approve the SD's proposed WG for the mining sector. The GSSB further expresses gratitude to everyone who volunteered to be part of the project.

 Session 4: GRI Topic Standard

Session 4: GRI Topic Standard Project for Biodiversity

- 76 Elodie Chêne, Manager Standards, presented the GSSB with the project update:
 - GRI has published two press releases relating to the biodiversity project. The first
 communication announced the alignment of the standard development process with the
 EFRAG Task Force, and the other was an announcement of the collaboration with CDP and
 TNFD.
 - GRI has joined EFRAG's biodiversity cluster meetings and provided feedback on the Standard proposal.
 - GRI has also invited EFRAG to join initial conversations with TC members to inform each other throughout the process.
 - As CDP is represented in the TC, the collaboration will aim to harmonize approaches to disclosures on biodiversity.
 - GRI will be part of the TNFD process through their forum and as a knowledge partner. There is an expectation that the revised GRI Standard would provide input on the risk management and disclosure framework. Completion is earmarked for the end of 2023.
 - The project has commenced with an initial scoping survey and interviews with TC members to identify the main work areas for revising the Standard.
 - An exposure draft is to be made ready for public comment in the May-June period.
