The project aims to identify and describe 25 likely material topics and relevant disclosures for reporting for the mining sector.	Project team
New topics to the GRI system based on WG feedback include Artisanal and small-scale mining, Conflict-affected and high-risk areas, and Tailings.	Project team
The draft has undergone an additional peer review as well as technical and editorial reviews by the Standards Editorial and Publishing team.	Project team, SE&P
In response to feedback from WG and external stakeholders, SD proposes to capitalize the term 'Indigenous Peoples' in the exposure draft.	SD, SE&P, Communications
Public consultation of the exposure draft will take place between 7 February – 30 April, including global webinars and regional events to engage external stakeholders.	SD, Communications, Regional Hubs

GSSB question/concern	SD response	Action
GSSB member asked about the rationale for taking out carbon dioxide and methane in the topic statement for GHG emissions.	The two examples are seen as limiting for the mining sector, and WG feedback proposed broadening the scope.	Project team
GSSB member noted that the sector profile did not adequately cover the negative impacts of the mining sector, although this was covered in topic descriptions. Moreover, mine site reporting is a positive evolution in sustainability reporting.	The sector profile was an example of consensus building with the WG. We welcome specific inputs on the sector profile.	Project team
